#### GENERAL TERMS AND CONDITIONS

These General Terms and Conditions form a legal and binding agreement between the you and FIS-FTPL and is made pursuant to the terms of the Information Technology Act, 2000.

## 1. ELIGIBILITY

You represent and warrant that you (a) are at least 18 years old.
